PURPOSE:

The purpose of this request is to initiate and award new competitive procurements for consultant services and/or modifications to existing contracts for critical consultant resources in support of and upgrades to major applications including PeopleSoft, Maximo and Trapeze. This procurement is for a base year (FY09) only.

DESCRIPTION:

Information Technology (IT) has implemented Metro enterprise software applications supporting the major business and operational areas of the Authority.

This action is to provide support for these critical systems and provide continuity of support during FY09. The details are as follows:

Support for the major upgrade of Maximo (Maximo tracks, manages and reports on all maintenance activity for WMATA), including: train cars, buses, plant, tracks, structures, elevators, escalators, etc. from version 5.2 to version 6.3. This software upgrade is a critical capital development effort that will allow WMATA to remain on supported software for this critical application.

Ongoing support for PeopleSoft - Human Capital Management, Finance & Supply Chain, and Customer Relationship modules

Support for the major upgrade of PeopleSoft. This is the re-implementation of the PeopleSoft Human Capital Management suite.

Ongoing technical support for Trapeze (Trapeze schedules buses, rail and staff assignments).

Ongoing technical support for Maximo.

Operational support is funded out the IT FY09 operating budget and technical integration and system upgrade development support is funded out of the IT Metro Matters budget.
