## TITLE:

Enterprise Architecture (EA)

### **PURPOSE:**

The purpose of this action is to obtain Board approval to initiate and award a competitive procurement to provide consulting services in support of the design and implementation of capital programs in support of the Enterprise Architecture program, including staffing the oversight of the Metro Channel. This action is for a base year and four one-year options. The option years are not obligations and are subject to approval of future year budgets. The Metro Channel oversight staff will be funded as part of the Metro channel program once the award for that contract has been made.

#### **DESCRIPTION:**

The consultants provided through this action will provide program oversight on the award, development, and deployment of the Metro Channel RFP and will perform business process analysis in support of capital projects within the Enterprise Architecture effort.


