TITLE:

IT Basic Ordering Agreement

PURPOSE:

The purpose of this action is to obtain Board approval to initiate and award, through a competitive procurement, one or more basic ordering agreements for providing Information Technology services in support of major IT capital initiatives. This action is for a base year (FY 2009) and four one-year options. There is no obligation for any of the option years. Option years are contingent upon approval of future year budgets.

DESCRIPTION:

The Authority has ongoing requirements for temporary expert technical assistance on a full or part time basis on capital projects in Information Technology disciplines. These disciplines include program management, technical training, technical writing, and business analysis as well as analysis, administration and engineering in the following technical domains: data and voice networks, wireless networks, enterprise applications, technical infrastructure, IT security, data and database management, systems software, internet and web programming, geospatial systems, enterprise architecture, business process reengineering, and enterprise integration. In addition to these fundamental IT disciplines, the authority will also require intermittent support from subject matter experts (SMEs) in areas which require special expertise.

The creation of basic ordering agreements provides a selection of vendors who have been pre-competed and gives a greater ability to leverage the DBE vendor population. These contracts are similar to those that are currently in place in Fairfax County, VA. as well as the District. They are similar in nature to the contracts the Authority has with Arinc and P2D. Task orders would be issued on

an "as needed" basis to vendors awarded basic ordering agreements in each of the disciplines. Each qualified vendor in a given discipline would be requested to submit proposals for each task order and awards will be made on a best value basis.

Basic Information Technology Ordering Agreements

Project Description: This action requests approval to initiate and award, through a competitive procurement, one or more basic ordering agreements for providing Information Technology (IT) services in support of major IT capital initiatives.

Benefit to Customers

- Permits the Authority to satisfy on-going requirements for technical support on capital projects
- Awards competitive, basic ordering agreements to multiple vendors in specific IT expertise categories
- Qualified vendors in several IT disciplines will be asked to submit proposals; and basic ordering agreement awards ("Licenses To Hunt") will be made to selected vendors on a best-value basis
- Provides a greater ability to identify and leverage the DBE vendor population
- Allows for quicker turn-around time to acquire temporary, expert technical assistance, because contracts are pre-negotiated
- Issues individual task orders competitively on an "as needed" basis to vendors who have been awarded basic ordering agreements in each of several IT disciplines
