Questions

- Q1. Are the sign requests supposed to be in inches or feet?
- A. Please see updated Price Schedule Sheet.
- **Q2.** Can you provide additional details on the material, thickness, height, width, etc. on the miscellaneous/undetermined sign request?
- A. Price out an equal average of all the sign sizes.
- Q3. What is your standard to determine regular shipping vs. rush shipping?
- A. Rush shipping is same day or next-day delivery.
- Q4. Are the amounts a real or just an estimate and are they the amounts per week, month, 1 year or 5 years?
- A. The amounts are estimates and they are per year.
- **Q5.** Regarding the statement below, found in the statement of work, does this only reference a mistake on the vendors part, which would not include a mistake found in a client approved proof?

In the event there is an error identified after the product has been completed, it is the responsibility of the vendor to address and correct at their expenses, within the mutually agreed upon timeframe.

- A. This references a vendor mistake.
- **Q6.** When high volume/quantity layout and signs are requested in 24 hours, the scope in most cases does not allow for proofing and completion of production to be done by any provider. Can you consider modification of the time to allow progressive completion of the order without penalty to the provider?
- A. Yes, there will be consideration given, if it is WMATA's high volume/quantity request.
- **Q7.** Is there a difference between the Coroplast 30"x24" double sided and the Coroplast 30"x24" single sided?
- A. One is printed on a single side and the other is printed on both sides (double sided).
- **Q8.** What is the w x h of the 1/16' Plastic with raised braille, Outdoor Long Term Banners with grommets, large size, Plastic short Term Banners with grommets, medium size, and the PVC Signed Panels?
