- 1. This solicitation is quite unique. The requirements are very comprehensive and a few of the provisions and SLA's present challenges which could be hard for vendors to meet. To this end, though you have categorized the solicitation as an "IFB", is it possible for WMATA to change its award criteria from "low cost" to "best value"? Response: No. The decision was made to use the IFB as the vehicle which is based on price alone.
- 2. Would WMATA be amenable to expanding its evaluation criteria with a weighing formula for the Technical" as well as "Pricing" aspects of the proposal?

Response: Technically acceptable lowest price will apply for the award.

3. The solicitation instructed the vendors to include the flexibility for WMATA to cancel 20% of the fleet through the duration of the contract. Would WMATA be amenable to reducing this requirement to 10% of the fleet for the duration of the contract?

Response: While we do not believe that this option will be exercised, the flexibility is at 20%

4. In Section 8.0, is it a requirement to utilize the HID Proxy Card or PIV Card for authentication or can WMATA utilize a PIN authentication?

Response: No - Authentication must be with a 2-factor card or chip.

- Will there be another public bid opening at 2pm on due date of May 30, 2018?
   Response: the bid opening will take place as expressed in the solicitation and above
- 6. Under "Price Schedule" please define what you mean by Unit of Issue? Response: This is referring to how the machine is identified as in, each etc.
- 7. Under "Price Schedule Option Years" please define what you mean by Networked? Response: Please discard.
- 8. Are any Bonds required? Response: No.
- Section 18.0 WMATA supplies the Servicing Locations of the current devices. Can WMATA identify the type of devices and # of color and B&W devices associated with each location?
   Response: Due to the portability of these devices, accurate location cannot be provided at this time; the number of makes are provided as part of this SOW
- 10. Section 2.0 what ticketing system does WMATA currently use to track and close service requests? Is it necessary to connect the contractor systems to the WMATA ticketing systems?

Response: WMATA currently uses CA Service Desk ticketing system. The preference is for contractor system to integrate with WMATA incident management system.

- 11. Section 2.1 WMATA does not have CLINS for the service, labor and management components of this RFP. Will WMATA consider creating clines specifying the labor desired and required?

  Response: This is not an RFP it is an IFB. All costs should be included in your proposal.
- 12. Section 2.1 Please define the roles of the on-site staff to allow a determination of the skill sets needed. Is WMATA requiring On-site First Responders with the expectation that more involved service requirements will be escalated to meet SLAs?

Response: These should be first responders with skills to resolve non-complex issues

- 13. Section 2.6 Is WMATA providing storage areas for toner and supplies for the devices to be managed? Response: Yes
- 14. WMATA is asking for a roadmap for a future state for the printing needs of the agency. Will WMATA add a CLIN for the Pre Award assessment and consulting to provide this service?
  Response: No. WMATA will not add a CLIN
- 15. Section 2.6 Does WMATA have a Print Policy that details how users are to be directed to reduce printing or to direct printing to approved larger volume print jobs? If so can it be shared with bid responders? Response: WMATA currently does not have a Print Policy aimed at reducing printing
- 16. Is CAC/PIV employed with the current devices? Response: No
- 17. If WMATA does not post the response to the questions by May 22 will you extend the bid by 6 days in order to allow ample time for the Vendors to respond and provide best value to the Government?

  Response: Responses will be provided by May 22.
