- 1. Proposal Due Date: Proposals are due on or before 2:00pm, March 13, 2018.
- 2. Period of Performance:

The period of performance is include a five (5) year base period and two (2) one year option periods

Base Period: (5) Five Years Option Year 1 Period: (1) One Year Option Year 2 Period: (1) One Year

The Authority has the unilateral right to extend this Contract by exercising up to two (2) one year option periods subject to all terms and conditions stated herein.

The Authority may exercise the option(s) (if any) by written notice to the Contractor prior to commencement of the option period; provided, that the Authority shall give the Contractor a preliminary notice of its intent to exercise an option within a reasonable time before the Contract expires. The preliminary notice does not commit the Authority to exercise an option.

- 3. Per the Scope of Work 2.1.5: The contractor shall pay WMATA the agreed-upon amount for advertising sales to terms proposed and agreed upon. The contractor shall also reimburse WMATA for staff time needed to upload and test advertising messages on its buses according to terms proposed and agreed upon as part of this procurement process.
  - 2.1.5.1 Senior Bus Technical Systems Analyst or equivalent at the current loaded hourly rate.
- 4. Offerors shall submit proposal in three parts: Volume I, II and III. Revenue Sharing Method/Target plan shall be included only in Volume I Cost Proposal/Revenue/Financial.

Volumes shall be submitted in the following order:

- (1) Volume I Revenue/Financial One (1) original and one (1) copy of the Revenue/Financial offer to include supporting backup documentation.
- (2) Volume II Technical One (1) original and four (4) copies of the technical proposal.
- (3) Volume III Contractual One (1) original and any required copies of the completed, signed solicitation documents to include Representations, Certifications, Pre-Award Data
- 5. The Authority SBLPP policy applies to this procurement. Contract may be awarded to SBLPP or non-SBLPP offerors.
