- Q 1. The model number listed is an internal builders number by TransCold and is not publicly listed. Based on the description it is a 06D?537 and the voltage is 208/230. Can you provide this number in its complete form?
- A Manufacturer P/N 6DBESB4K2V64A011
- Q 2. The Bid lists "new" no used or recondition or older units what about 100 % remanufactured units to your specifications?
- A No Remanufactured New supplies ONLY
- Q 3. The delivery schedule lists 60 day timeline... is that 60 calendar days or 60 work days (Monday thru Friday)?
- A 60 Calender Days
- Q 4. Do you have cores to return for each unit? Exchanges
- A There are no Cores to be returned.
- Q 5. If I pay to have a sample sent to me and pay to return it (unless I win the Bid and use it for the Bid) is that possible?
